# **Halloween Trail of Tricks & Treats!**

## **VENDOR Instructions, Rules, & Codes of Conduct**

Friday, October 31, 2025 4:00 pm - 8:00 pm

Rubes Creek Trail, 232 Arnold Mill Road, Woodstock 30188 (Across from Fire Station 14) Parking is located at the Allen Temple AME Church next to the paved and lighted trail.

The Halloween Trail of Tricks & Treats takes place on the **paved and lighted** Rubes Creek Trail on Arnold Mill Road across from Fire Station 14. Vendors line the sides of the trail along with fun skeleton and inflatable displays, carnival games, giant bubble making, a bounce house, and music to make the walk extra exciting for the kids. Each vendor must provide a free game, craft, or activity for the kids in order to participate. We expect 2,000 participants each year!

#### **REGISTRATION & PAYMENT**

Vendor registrations must be submitted by the deadline of October 24, 2025.

ALL Vendors are chosen at the discretion of City of Woodstock event staff, not by first come, first served.

All Vendors agree to display and sell only those goods described on their registration.

Your registration can be denied for any reason.

You must have all of your staff/volunteers sign the Group Accident/Liability Waiver. We will pick up at your booth at the start of the event.

Vendors agree to be present for all scheduled event hours.

#### **CANCELLATIONS**

Any cancellations by applicant will result in the forfeiture of all fees.

There will be no rain date.

There will be no refunds because of the weather *unless* the City of Woodstock cancels the event due to inclement weather.

The City of Woodstock reserves the right to cancel an event for any reason at any time.

Check the website before heading out to any event.

If you are required to provide a certificate of insurance and don't, your registration will be cancelled with no refund.

#### **REFUNDS**

We do not guarantee sales, participation, or visitation by event guests to your booth area.

Event staff have the right to assign vendors booth space to areas at their own discretion.

No refunds will be given based on lack of sales, location of booth, competing Vendors, etc.

Submitting your registration in early does not guarantee you a certain space on the trail.

If you are required to provide a Certificate of Insurance and don't, your registration will be cancelled with no refund.

#### **WEATHER POLICY**

It is a rain or shine event, unless inclement, severe, extreme, or unsafe weather rolls in.

Bring tarps, tent sides, or drop cloths for quick cover if rain occurs unexpectedly. Tents are recommended.

Check our website or Facebook page for delays or cancellations.

You will be notified via e-mail and phone call, if necessary, in the event of a delay or cancellation.

Every effort will be made to put on the event including a delay in starting the festival due to severe weather.

We will plan for the festival to go on as usual until then.

THE EVENT WILL NOT BE RESCHEDULED.

#### **FOOD VENDORS**

Food Vendors will be limited to prepackaged foods and beverages only.

No cooking on site, electricity and water are <u>not</u> available.

Sorry, no food trucks or trailers.

All Food Vendors must comply with all applicable Department of Environmental Health Food Handling Guidelines.

#### **ELECTRICITY – GENERATORS**

There is **no** electricity on site.

Vendors can bring a QUIET generator and at least a 50' extension cord with them.

A battery-operated lantern or lights at your booth is recommended.

You may bring your own generator. Quiet generators only. Please let us know if you are bringing one.

#### **ALCOHOL**

Consumption or sale of alcoholic beverages is strictly prohibited.

For safety reasons, no alcoholic beverages are allowed to be consumed at any time by Vendors during the event.

Any Vendor believed to be under the influence of any intoxicating or impairing substance will not be allowed to participate in the event.

#### **DRONES**

WARNING: All unmanned aerial systems/vehicles, drones, or other flying devices are strictly prohibited.

#### **BOOTH SPACE**

Your booth space comes with one 8' rectangular table, and two chairs. You are welcome to bring a tent, extra tables, extra chairs, etc.

Vendors are responsible for the set-up and take-down of their own booths.

All Vendors will decorate their booths in an attractive manner, and are responsible for providing their own set-up materials including tents, <u>additional</u> tables, chairs, etc.

All displayed items must be appropriate for family viewing, including young children.

Conduct on the part of any Vendor that may embarrass the City of Woodstock will be cause for immediate removal from the event by the event officials.

Please dispose of trash in the provided trash bag. Leave the bag at your site for staff to pick up after the event.

Vendors are required to keep their booth space clean, neat, and free of hazards.

Vendors will not engage in behavior that unreasonably endangers the safety of any person at the event.

## **SET UP & TAKE DOWN DETAILS**

#### TRAIL TRANSPORTATION

After parking in the Allen Temple AME Church Parking Lot, our staff will help load your things onto our trail vehicle and drive you to your booth site. Any fragile items should be held in your lap.

An 8' rectangle table, two chairs, and trash bag will be at your site for you when you arrive.

This assistance will not be available after 3:45 pm.

After the event, pack up your site and one of our staff will be there to take you back to your vehicle.

#### LOAD IN / OUT INFORMATION

After checking in, Parks and Recreation Staff will help load your items onto one of our trail vehicles and take you to your booth site.

Please do not bring extremely fragile items. Please hold them in your lap if necessary.

You will not be allowed to unload prior to your load in time, this is strictly enforced as staff will not be available to transport you to your booth site.

Vendors agree to have their booth set up and ready for business by the start of the event which is 4:00 pm.

Everything must be removed from the trail immediately after the event.

Anything left overnight will be considered abandoned and disposed of accordingly.

Vendor parking is located at the Allen Temple AME Church next to the trail. Please, park there where you will check in and be transported to your booth site.

It is extremely important that you arrive at your set up time. We will not be able to transport you after 3:45 pm.

Anyone attempting to load in early will have to wait in the parking lot until their set up time.

Those arriving after 3:45 pm will have to walk the trail to their site. No refunds for late arrivals.

No early breakdowns.

## **EVENT & LOAD IN/OUT TIMES**

**2:00 pm** Vendor set up begins.

3:30 pm Vendor set up ends.

**3:45 pm** Transportation ends.

**4:00 pm** Festival begins.

8:00 pm Festival ends.

**8:15 pm** Transportation resumes once the trail is cleared of pedestrians.

See Vendor directions, load in times, instructions, code of conduct, and load in map on the website.

These are extremely useful and necessary. Please share with other members of your group.

#### **GENERAL RULES & CODES OF CONDUCT**

Vendors will not engage in behavior that unreasonably endangers the safety of any person at the event.

Conduct on the part of any Vendor that may embarrass the City of Woodstock will be cause for immediate removal from the event by the event officials.

Vendors whose sole purpose is to advocate for a particular candidate, political party, or religious belief, must do so in a positive manner which would not disparage any other entry, political party, candidate, or religious belief. Any Vendor that violates this rule is subject to removal from the event.

The City of Woodstock's events are not partisan. The City has determined there are adequate venues for public demonstration and protests, and that active civil disobedience during the event would be detrimental to the goals and purposes of the event.

The City of Woodstock reserves the right to refuse an entry into the event if, in its sole judgement, it determines that the entry is controversial, unlawful, obscene, vulgar, defamatory, offensive to local community standards, or otherwise considered to be inconsistent with the standards, theme, quality, or purposes of the event.

Any points not covered above or elsewhere are subject to settlement by the City of Woodstock Event Management. Any violation of these rules and regulations by any Vendor could forfeit all monies that have been paid. The City of Woodstock and Event Management reserve the right to terminate the agreement for booth space. Written notice by Event Management to terminate the agreement for booth space is not required.

Vendors assume all responsibility for loss or damage of any kind to their property during events. Vendors agree to indemnify and defend said event(s), the City of Woodstock, and its employees against all claims or expenses arising out of the use of exhibit space.

Submission of registration signifies acceptance and compliance of rules and codes of conduct. Participants agree to abide by all rules, instructions, and decisions made by event officials. Failure to abide by rules, instructions, and decisions are grounds for removal from the event. It is the responsibility of each Participant to ensure that everyone in their organization is aware of and agrees to comply with these rules. Flagrant violations of these rules may prevent future participation by that organization and/or individuals involved.

I agree to the terms of this registration and will instruct members of my organization and/or volunteers to abide by its instructions, rules, and codes of conduct.

I agree to have every staff/volunteer at my booth sign the <u>Group City of Woodstock Accident/Liability Waiver</u> prior to the start of the event. I agree to have the signature sheet ready to be picked up at the event by City of Woodstock staff before we will be allowed to participate in the event.

You will need to print a copy of the group waiver. Failure to read and understand these directions could lead to disqualification from this and future events.
